LIABILITY RELEASE AND WAIVER AGREEMENT

In consideration for my participation in sailing activities associated with the St Kitts Yacht Club (including the Summer Sailing Camp),, the undersigned participant (“Participant”), and if such Participant is a minor, the Participant’s parent or legal guardian, and their respective heirs, executors, administrators, personal representatives and next of kin (collectively with Participant, “Releasers”), hereby forever waive, release and discharge the St Kitts Yacht Club, its affiliates, and their respective members, managers, employees, volunteers, officers, directors, agents, representatives, successors and assigns (each a “Released Party”) from any and all claims, demands, damages, judgments, executions, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, which a Releaser may have, or claim to have, against any Released Party resulting from death, personal injury, property damage or other loss Releaser may sustain as a result of participating in any sailing activity associated with the St Kitts Yacht Club, other related activities (including land-based activities), or the use of the St Kitts Yacht Club’s equipment and facilities), or the use of any of the St Kitts Yacht Club’s equipment, either on shore or being prepared for sailing or while sailing, and any of the SKYC facilities.

Where participant causes property damage or injury to 3rd party or 3rd Party’s property while using club property (e.g. boat), the participant should solely be liable for such damage to the SKYC property and to any liability caused to third parties property or person.

This Release is intended to discharge each Released Party from and all liability arising out of or connected in anyway with participation in Sailing Activities associated with the St Kitts Yacht Club, even if that liability arises out of negligence or carelessness on the part of any released party.

Releasers hereby acknowledge that serious accidents occasionally occur during sailing activities and that mortal or serious personal injuries and/or property damage or other loss may result from participation in sailing activities, including further injury or damage sustained as the result of the efforts of third parties who come to the aid of Participant. Releasers hereby agree to indemnify and hold harmless the Released Parties for claims, demands, damages, judgments, executions, rights of action or causes of action relating to any such injury or damage.

Participant hereby agrees to pay the St Kitts Yacht Club for loss or damage due to Participant’s intentional, negligent, or careless use or misuse of equipment (including boats) or facilities. Participant further agrees to abide by all rules and instructions of the St Kitts Yacht Club or its representatives or agents relating to participation in sailing activities associated with the St Kitts Yacht Club and Participant agrees that his or her the failure to observe and obey such rules may result in revocation of the right to participate in any such activities without further recourse.
